The equipment downtime has been caused by below reasons directly or indirectly. (1) misuse, negligence or operational errors, (2) Improper environmental conditions (i.e. not in line with the requirements of Elekta for the environmental conditions), including but not limited to requirements of temperature, humidity, power supply, such as voltage, frequency, pulse or instantaneous current, etc. Natural disasters or other force majeure events specified in force majeure. The above reasons are applicable only if Party A fails to make the rectification after receiving Party B's written notice for Party A.

4. 责任与义务

Responsibilities and Obligations


